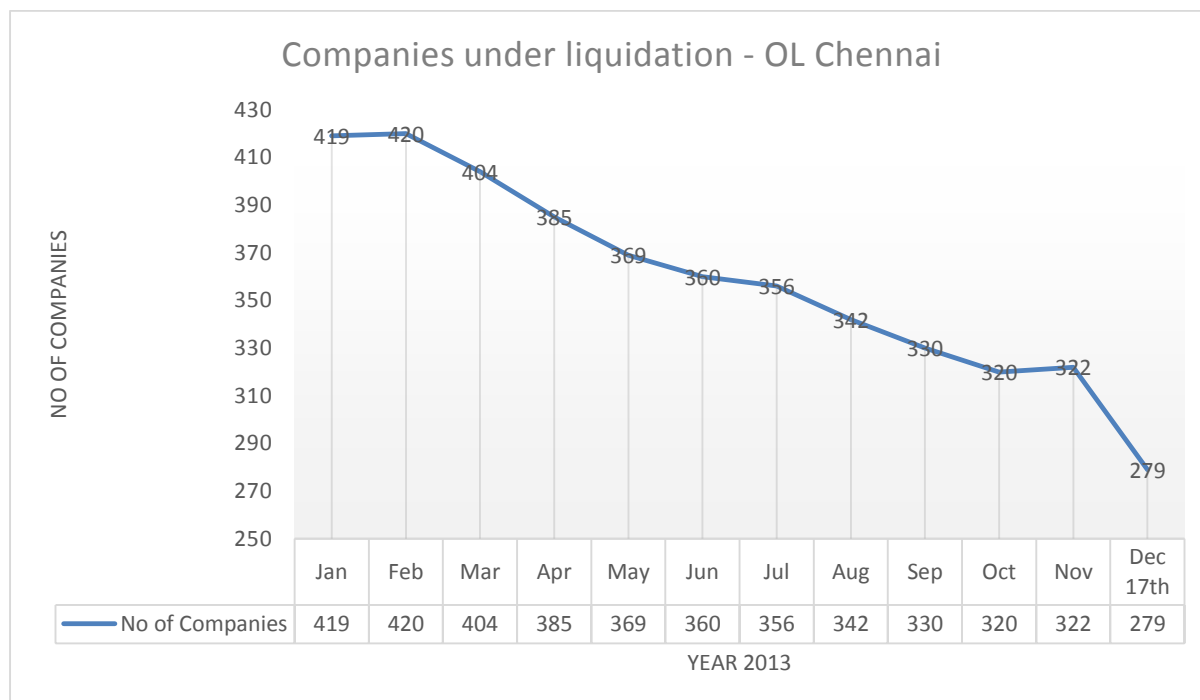


Honouring a commitment

With the able guidance of the Honourable Company Court, Madras High Court, we have been able to dissolve a further 43 companies during the period, apart from the 92 companies that were already dissolved during this calendar year thereby reducing the number of active companies being dealt with the office to 279. A graphical representation of the same is as shown below.



Further over 20 companies under voluntary dissolution have also been dissolved in the Two and a half month period.
